Mineral Claim Registered

On 27 May 2015, the Mining Registrar within the Department of State Development (DSD) registered Mineral Claim 4383 over the proposed mining lease area at Warramboo. The Mineral Claim does not give Iron Road the right to mine; rather, it provides the exclusive right to apply for a mining lease over the area of the mineral claim within 12 months.

Mining Lease Proposal and Environmental Impact Statement

As we are drawing closer to submitting the Central Eyre Iron Project (CEIP) assessment documents with government, we want to ensure that community members are prepared for the publication of both the Mining Lease Proposal (MLP) and the Environmental Impact Statement (EIS). Once these documents are made public by government there is an opportunity for all stakeholders, including impacted landowners, Councils and members of the local community, to read through all information about our proposed development and raise any concerns that they feel have not been adequately addressed either through our engagement over the past three years or within the documents themselves. This process will be facilitated by the State Government through the Department of State Development (DSD) and the Department of Planning, Transport and Infrastructure (DPTI).

CEIP Community Perception Survey

Iron Road recently engaged a South Australian, independent research firm to undertake a community perceptions survey across the part of the Eyre Peninsula that will be affected by the CEIP, including the town of Lock and the District Council areas of Wudinna, Cleve and Tumby Bay.

The purpose of the community survey was to provide a pulse check of current stakeholder perceptions of the key impacts of the CEIP, Iron Road's engagement performance to date, and to inform the company's engagement strategy moving forward. The information collected will be used to support the MLP and EIS documents to confirm Iron Road has addressed all key concerns and benefits raised in those documents and to ensure we continue our engagement on a level that the broader community sees as effective and beneficial. The survey results will also serve as a foundation for future surveys to measure Iron Road's progress in the community and how stakeholders respond to the CEIP as changes begin to occur (e.g. construction and operations).

Local Adelaide research firm 'Square Holes' were engaged by Iron Road to undertake the survey, first consulting with the company on developing the questionnaire before carrying out the survey and collating the research data.

The survey results will be included in both our MLP and EIS documents and made available on the Iron Road website in due course.

'Talking Topic' presentations to be available on the Iron Road website

There has been some interest from community members who did not get the opportunity to attend talking topic sessions to access the information that was presented. Most specifically, the 'Water' and 'Air Quality' presentations were of interest and will be available shortly on our website, with commentary notes attached to help with the context of the presentations. Much more detailed technical information will be available within both the MLP and EIS documents when they are released by State Government for public consultation.
